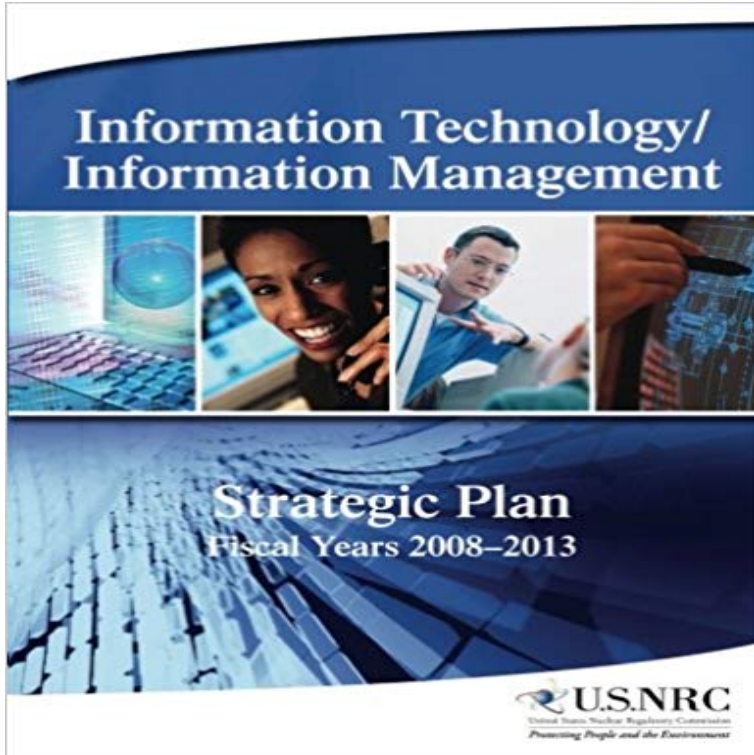


Information Technology/Information Management: Strategic Plan Fiscal Years 2008-2013
