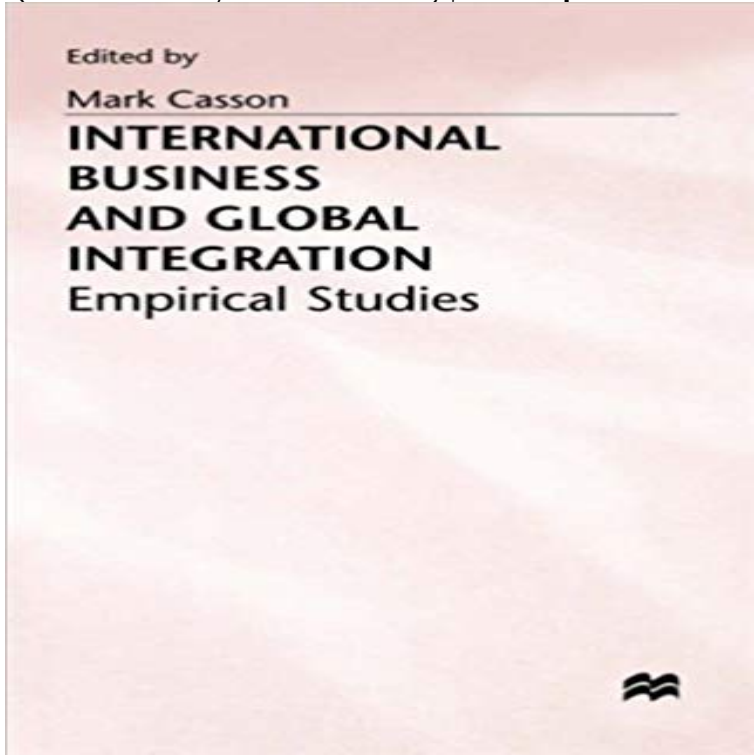


International Business and Global Integration: Empirical Studies (University of Reading European and International Studies)

They have promoted intra-firm trade, technology transfer and internal movements of capital and human resources. Particular attention is given to the participation of multinationals in management contracts and joint ventures, and the significance of this for host country industrial policy.
